International Experience Program abbreviated as IEP is a step forward from GTU in the direction of becoming an “**International Innovative University**”. The program was initiated in 2011. Currently IEP is one of the largest student mobility programs offered by the technological universities of India. Since the inception of the program, more than 2370 students have participated in IEP & received numerous benefits in shaping their career.

Under this program, students’ study two or three subjects of their final year at the foreign university. Students also appear in internal examination, continuous evaluation and external examination conducted by the foreign professors at foreign university. If student achieves the passing grades in the exams, he/she will be given the waiver for appearing in the internal and external examination of GTU for respective subjects. Apart from the above-mentioned subject-learning experience, students also prepare the projects and case studies as decided by the foreign professors. They also visit the companies to enhance their understanding on the work culture of the foreign country in their respective fields. This unique educational journey not only provides a comprehensive academic experience but also fosters a rich socio- cultural experience with practical understanding of global work environments to become a true “Global Citizen”.

Upon completion of the program, students return to their parent college and seamlessly integrate into their final year.

2. For MCA:

- Students of MCA first year of GTU can apply.
- Semester: Students who are going to give exam of **Semester II of MCA in Summer 2024**
- Students will be selected based on the result of graduation (first come first serve basis)

NOTE: CPI & backlogs of only regular semester IV exam (summer exam 2023) shall be considered for the eligibility. The updates in the results of semester IV after remedial exam of Winter 2023 session shall not be considered for the eligibility criteria.

*Final selection will be done purely on merit basis w.r.t the available seats

TENTATIVE DURATION OF IEP - 2024:

- End of June 2024 – 2nd week of August 2024 (Approximate days- 45) shall be tentative duration of IEP 2024 at LU, Canada.
- Selected student will travel to Canada Immediately after the completion of end semester exam of semester – 6/Semester 2 in summer 2024.
- The duration and number of days may vary in case of any unexpected situation/factors impact the program adversely.


