# **INSTRUCTIONS TO APPLY ONLINE FOR IEP**

# **Before You Begin**

#### Please note:

- 1. Use Mozilla Firefox (version 47.x and above) or Google Chrome (version 53.x and above) for Registration.
- 2. Once you click the "Registration" button, the Application will become active.
- 3. All information is mandatory unless specified otherwise.
- 4. Before you submit your application, you will have the opportunity to save your work and continue at a later time if you wish to do so.
- 5. Before you submit your application, please ensure that all the required information is filled accurately. You will not be able to edit your information after submission.

#### **Important additional information**

- 1. You are advised to keep your 'login credentials' for your reference.
- 2. Please quote the 'IEP Registration Number' and 'Country' in the subject line in all your email correspondences with us without fail.
- 3. You **NEED NOT** send us the hard-copy of the application form. **Only shortlisted students are** required to submit hard copy of application form along with required documents through proper channel to GTU, Chandkheda campus.
- 4. Payment of confirmation fee has to be done **Online.** Only shortlisted students are required to pay '**Confirmation Fee'** for further process of applying for visa.

# **STEP 1: REGISTRATION**

- 1. Go to <u>http://international.gtu.ac.in/</u> and click on 'IEP' tab. You will be redirected to the home page of 'IEP'.
- 2. Click **'REGISTRATION'** on the left hand side.



3. Read all terms & conditions thoroughly and accept the same before starting the registration process.

- 4. Enter a valid Enrollment Number and press '**verify**'.
- A screen having details of student will be displayed. Student is required to verify the email address. Please enter valid email address if the prefilled Email ID is wrong as all the communications from GTU will be done on this Email ID.

Note: Students of MBA/ MCA lateral entry are advised to follow the instructions given on page no. 5 of IEP Handbook.

### **STEP 2: APPLCATION FORM (PASSPORT DETAILS)**

 It is mandatory to have passport\* to apply for IEP. Student has to enter following passport details - Passport Number, Passport Issue Date and Passport Expiry Date. Please make sure that passport is having expiry date of more than one year from the date of applying for IEP. This will help in avoiding any issue during the travel to foreign country.

\*As the online application will remain open for approximately one month, interested students who do not have passport may get TATKAL passport to apply for IEP.
